

### **American Connectivity Program**

(ACP) provides a monthly broadband subsidy for lowincome households. Up to a \$30/month discount on monthly internet service

Up to a \$75/month discount for households on qualifying Tribal lands

A one-time discount of up to \$100 for a laptop, tablet, or desktop computer (with a co-payment of more than \$10 but less than \$50)
